

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to the eferralonline.com and Eferral Inc and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Eferral Inc include eferralonline.com and Eferral. The Eferral website is a Secure Messaging system site. By using the Eferral website, you consent to the data practices described in this statement.

Collection of your Personal Information

Eferral may collect personally identifiable information, such as your name. If you purchase Eferral's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction. We may gather additional personal or non-personal information in the future.

Information about your computer hardware and software may be automatically collected by Eferral. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Eferral website.

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through Eferral's public message boards, this information may be collected and used by others.

Use of your Personal Information

Eferral does not sell, rent or lease its customer lists to third parties.

Eferral may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Eferral, and they are required to maintain the confidentiality of your information.

Eferral will disclose your personal information, without notice, only if required to do so by law or in

the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Eferral or the site; (b) protect and defend the rights or property of Eferral; and, (c) act under exigent circumstances to protect the personal safety of users of Eferral, or the public.

Security of your Personal Information

Eferral secures your personal information from unauthorized access, use or disclosure. When personal information (such as a credit card number) is transmitted to other websites, it is protected through the use of encryption, such as the Secure Sockets Layer (SSL) protocol.
